SUBMISSION DEADLINES

Title in 15 words or less, capital letters.

Data from each author and co-author(s): Name and last names. Then, separated by commas and in the following order: email, home institution and country, position, academic degree -if holding one- and specify if being a student.

Abstract: in less than 250 words including problem, objective, methodology and results + key words.

Full paper: Papers presented will be submitted to a blind review process using standardized criteria by external readers for inclusion in the Conference Proceedings.

Typing: Arial 10 points, 1.5 space, margins: upper and bottom 2.5 cm; right and left, 3 cm; Letter format, Word processor MSWord/Open Office.

References: following APA 6th edition, citation index.

Length: 10 and 15 pages.

LANGUAGES

Presentations can be given in Spanish, English or French. Portuguese is also accepted. The proposal should be submitted in the language that it will be presented. Proposals submitted in languages other than Spanish, should include a summary in Spanish. Proposals submitted in Spanish, French or Portuguese, should include a summary in English.

Interpretation from Spanish to English, English to Spanish will be provided in plenary sessions only.

DEADLINE

Abstracts: August 1st, 2018.

Notification of acceptance: August 15th, 2018.

Full Paper: September 15th, 2018

The conference organizers aim at carrying out a collective publication of the most outstanding papers, whose publishing standards, deadlines for the final version of the works selected by the scientific committee, will be sent well in advance to the authors.
